

Vocational Courses at Bay Leadership Academy

Overall Guidance

The Department for Education (DfE) has completed a review of all courses that schools have approval to offer as part of the curriculum. Examination boards have developed new courses to ensure that new vocational subjects are as rigorous as the new tougher GCSEs.

These new vocational courses have the DfE 'Technical Award' status. To be recognised as Technical Awards, qualifications must focus on developing sector-specific knowledge and technical skills in a practical learning environment. They must also have a significant external exam element, allowing pupils to gain high-quality grades. Technical Awards form a valuable part of the Key Stage 4 curriculum as they allow for both academic and vocational progression.

All of our vocational courses meet this standard and are DfE approved Technical Awards.

The table below shows you how the DfE, colleges and further education providers compare vocational grades with GCSE grades. For example, a Level 2 Distinction is equivalent to a new GCSE Grade 7. All of the courses we are offering allow pupils to gain a Level 2 Distinction*, which is equivalent to a GCSE grade 8 and 9.

Course details: CREATIVE iMEDIA

60070432	OCR Level 1/2 Cambridge National Certificate in Creative iMedia

About this qualification

The Cambridge National Certificate in Creative iMedia is an IT-based Technical Award. It will equip learners with a range of practical IT skills and provide opportunities to develop, in context, desirable and transferable skills valued by both colleges and employers. The 'hands on' approach that will be required has strong relevance to the way young people use the technology today. These include creating digital products and website design using 2D and 3D graphics combined with digital animation.

Assessment

This course is made up of 4 units. These include 3 OCR Set Assignments and one written examination. This allows pupils to be assessed on both their written and practical IT skills. Each of the OCR Set Assignments are completed by pupils during 10 hours of curriculum time. These assessments are completed in controlled conditions and pupils' work is moderated by OCR. In addition, to the OCR Set Assignments there is a formal written examination lasting 1 hour and 15 minutes.

Course details: PHYSICAL EDUCATION (PE)

About this qualification

The new GCSE in Physical Education develops a holistic understanding of the subject. Stimulating content is at the heart of this engaging qualification. Students will receive a well-rounded and full introduction to the world of PE, sport and sport science through the combination of physical performance and academic challenges. Students will develop and maintain their performance in physical activities. Students will also gain understanding of how physical activities benefit health, fitness and well-being.

The course covers a full range of topics broken down into 4 distinct areas:

Practical Performances are formally assessed by the teacher and will consist of 3 assessments, each over a 12 hour period. This is moderated by Edexcel. The Personal Exercise Programme (PEP) is designed by the student and carried out over a 6-8 week period. This must be related to one of the 3 chosen practical performance tasks. Students must analysis and evaluate their PEP, which is formally assessed by the teacher and moderated by Edexcel.

Course details: ART AND DESIGN

60180882	AQA Level 1/Level 2 GCSE (9-1) in Art and Design

About this Qualification

The new GCSE in Art and Design develops skills through integrated practical, critical and contextual study that encourages direct engagement with original works and practice. Students will draw upon the work and approaches of both historical and contemporary artists while developing their own creative skills.

Students learn through practical experience and demonstrate knowledge and understanding of sources that inform their creative intentions. They engage with visual language, visual concepts, media, materials and the application of appropriate techniques and working methods. They will explore the ways in which meaning is conveyed through colour, texture, form, shape and tone.

Students will reflect critically upon their creative journey and its effectiveness in relation to the realisation of personal artistic intentions. This will be recorded through written annotation that supports and develops the creative process.

The Portfolio must include a sustained project evidencing the journey from initial engagement to the realisation of intentions and a selection of further work undertaken during the student's course of study. This work is set and marked by the teacher, then moderated by AQA.

The AQA Set Assignment is completed under supervised time for 10 hours, marked by the teacher and then moderated by AQA.

Note: There is no formal written examination.

Course details: ENGINEERING

60329634	NCFE Level 1/2 Technical Award in Engineering

About this qualification

The study of engineering is the application of maths and science to solve real world problems. This involves an understanding of the different disciplines of engineering and how they have shaped the products and projects of the modern world. Learners will be able to read technical drawings, select appropriate materials along with tools and machinery, and know how to carry out a practical task, working in a safe manner in line with current health and safety legislation.

This course is appropriate for students who are motivated and challenged by learning through hands-on experiences and through content which is concrete and directly related to those experiences.

Students will develop an understanding of properties and characteristics of engineering materials. They will know why specific materials are selected for engineering applications and use engineering tools, equipment and machines to work with them. Student will produce engineering drawings which are hand-drawn and some that use Computer Aided Design (CAD). Practical learning will take student through the full process of planning, production and review.

About this qualification

The new BTEC Tech Award in Performing Arts allows students to develop skills in acting, dance and musical theatre. Students will explore performance styles, creative intentions and purpose. They will investigate how practitioners create and influence what's performed and analyse performance roles, skills, techniques and processes.

Students will take part in workshops, classes and rehearsals enabling them to gain physical, interpretative, vocal and rehearsal skills. Students will apply these skills in performance, reflect on their progress and how they could improve.

The course is made up of three components: two that are internally assessed and one that is externally assessed. These take the student through the process of exploring and developing skills in Performing Arts, leading to the ability to conduct and review a final performance.

About this qualification

The Level 2 Technical Award in Hair and Beauty Studies allows students to gain theoretical knowledge and a small number of technical skills, related to the hair and beauty sector, not usually acquired through general education. The qualification develops the following skills:

- Specific services carried out within the hair and beauty sectors, roles and responsibilities and typical working patterns
- Evolution of hair and beauty from use in Ancient times to the mid-1990s
- How technological advancements, changes to the economy, and social factors have influenced the sector
- Chemistry of cosmetics and biology related to hair and beauty
- Uses of design and images for business use
- Technical hair styling, make-up and manicure skills.
